



GENERAL BOOKING AND CANCELLATION POLICY

Booking conditions

- **1st deposit**
Payment of a first deposit representing 35% from the total booking (minimum one night) is to be paid at time of the booking. The first payment is definitely kept by the hotel.
- **2nd deposit only for reservations over or equal to 5 rooms**
Payment of a second deposit representing 30% from the total booking is to be paid 90 days before the arrival.
- **Balance / Final payment**
The balance / final payment of the total stay has to be paid 60 days before the arrival for a reservation over or equal to 5 rooms and 30 days before the arrival for a reservation fewer than 5 rooms.

MEANS OF PAYMENT

Each payment has to be made either by:

- French cheque established in the name of HOTEL ANNAPURNA,
- Bank transfer, imperatively by SWIFT SYSTEM, to the following account number:

CANCELLATION POLICY (TOTAL OR PARTIAL)

For a reservation over or equal to 5 rooms

In case of total or partial cancellation, the fees due by the client are calculated from the total amount of the confirmed and cancelled booking as follows:

- from the date of reservation to 91 days before the arrival: 35 %
- from 90 to 61 days before the arrival: 65 %
- from 60 to 31 days before the arrival: 80 %
- from 30 days to the arrival: 100 %

CANCELLATION POLICY (TOTAL OR PARTIAL)

For a reservation fewer than 5 rooms

- from the date of reservation to 31 days before the arrival: 35 %
- from 30 days to the arrival: 100 %

This booking and cancellation policy is sent upon confirmation of the reservation. The present contract has to be returned to: Hotel ANNAPURNA, Route de l'Altiport, 73120 Courchevel, dated and signed by the client for agreement.

However, if we are able to resale totally or partially the cancelled or amended booking, the amounts charged would be placed in credit of the client who has cancelled and reported for a future stay.

Please note that in case of a no-show or of a later arrival and without the customers' manifestation in due time, the stay will automatically be cancelled, within 24h.
